IV. POLICY STATEMENT

Northwest Louisiana Human Services District (District) operates the website (Site) www.nlhsd.org. This policy informs users of the Site of our Privacy, Terms and Conditions policies so that users can make informed decisions regarding their use of the Site.

V. PRIVACY

In operating the Site www.nlhsd.org, our District may collect some personal information from users of the Site. The District uses your Personal Information only for providing and improving the Site or District services. By using the Site, you agree to the collection and use of information in accordance to this policy.

- A. Information Collection and Use: While using our Site, we may ask you to provide us with certain personally identifiable information that can be used to identify or contact you. Personal identifiable information may include, but is not limited to, your name, your parish of residence, your phone number, and your email.
- B. Log Data: Like many Site operators, we collect information (Log Data) that your browser sends whenever you visit our Site. This Log Data may include information such as your computer's Internet Protocol address, browser type, browser version, the pages of our Site that you visit, the time and date of your visit, the time spent on those pages and other statistics. We may use third party services such as Google Analytics to collect, monitor and analyze this Log Data.

- C. Communications: We may use your Personal Information to contact you with newsletters, marketing or promotional materials. You may opt out at any time by using our “Unsubscribe” link in the emails or by contacting us at www.nlhsd.org with your request.
